

All of us in Parish Outreach wish to thank those parishioners who donated or attempted to donate blood at our Blood Drive held last Sunday.



What does it mean to form my conscience?

Catholics have a long tradition of engagement in the public square. Sometimes that engagement requires making difficult moral decisions that impact our own lives and those of others. Our conscience can help guide the decisions we make. The Second Vatican Council guides us: "Always summoning [one] to love good and avoid evil, the voice of conscience can when necessary speak to [one's] heart more specifically: do this, shun that" (*Gaudium et Spes* 16). However, our conscience doesn't just come to us when we are born. We must work throughout our lives to form it through prayer, learning, and conversation.

How do I form my conscience?

It takes time to form our consciences so that we can make well-reasoned judgments about particular, real-life situations. The Church teaches that it is important to work continually on conscience formation so we can be prepared to make decisions whenever the opportunity arises. Some specific ideas to form your conscience are:

- Begin by being open to the truth and what is right.
- 2) **Study Sacred Scripture** and the **teaching** of the Church.
- Examine the facts and background information about various choices and be discerning in where we gather information.
- 4) **Prayerfully reflect** to discern the will of God (*Forming Consciences for Faithful Citizenship*, no. 18).

Additionally, it is important to consider how our community of faith can help us form good consciences through some of these steps:

- Seek the prudent advice and good example of trusted leaders and others to support and enlighten our conscience.
- 2) Learn about the **authoritative teaching** of the Church.
- 3) Pray for the **gifts of the Holy Spirit** to help us develop our conscience.
- 4) Regularly partake in an examination of conscience to hear God's voice in your life.¹

Doing the work of forming our consciences can seem daunting. Fortunately, we have many church teachings that can help us in this important task. Forming Consciences for Faithful Citizenship is an important resource for U.S. Catholics and helps us prayerfully reflect on how we can apply Church teaching in our civic life. "Conscience is not something that allows us to justify doing whatever we want, nor is it a mere "feeling" about what we should or should not do. Rather, conscience is the voice of God resounding in the human heart, revealing the truth to us and calling us to do what is good while shunning what is evil."²

Here are some questions for further reflection:

- When has my conscience guided me to "do good and avoid evil"?
- 2. What are some key resources I can use to form my conscience?
- 3. Forming conscience is a "lifelong task." What do I do to *regularly* form my conscience? What more should I do?

Proposal One - Ballot initiative to amend the NY State Constitution

Dear Brothers & Sisters in Christ:

As you may know, on the back of this year's general election ballot, you are asked to vote regarding a proposed amendment to the New York State Constitution.

Known as "Proposal One," if approved, this amendment would make it illegal under the New York State Constitution for any institution, public or private, to discriminate against an individual based upon such person's so-called "gender identity" or "gender expression."

The creation of a new constitutional right based upon gender identity and expression would have far-reaching negative implications for Catholic parishes, schools and health care facilities, as well as for secular institutions such as local and youth sports teams, gyms and restaurants.

The amendment contains broad and vague language that is supposed to prevent discrimination based upon "reproductive healthcare and autonomy." These terms could be read by courts to require Catholic health care facilities to perform abortions because the refusal to do so could be construed as a form of illegal discrimination against a person's "reproductive autonomy."

The religious liberty of the Church is, therefore, directly threatened, as this proposal could be used to force Catholic institutions to employ persons, or to engage in practices, that are manifestly contrary to the Church's teachings. Failure to adhere to these practices will expose our parishes, schools and hospitals to lawsuits for unconstitutional discrimination.

I ask you to visit the diocesan website, drvc.org, to read Bishop Barres' letter on Proposal One and to view a short video of his recent remarks on the matter.

In union with all the bishops of New York, Bishop Barres asks that all of us inform our consciences on this issue. Proposal One is a threat to our religious liberty and should be voted down in this year's election.



Dear Brothers and Sisters in Christ.

At this year's general election, New York voters will decide whether to approve a proposed amendment to the State Constitution. Officially known as "Proposal One", the amendment would add new language to the State's version of the "Bill of Rights" that, if approved, could insert gender ideology into child and adult sports, schools, hospitals, and even our churches.

The proponents of Proposal One refer to it as the "Equal Rights Amendment" and claim that the amendment is intended to protect the right to access an abortion. Proposal One, however, does nothing to ensure "equal rights" nor does it have anything to do with the legality of abortion in New York.

Since 1938, the State Constitution has guaranteed the right to the equal protection of the laws and has barred discrimination against any individual by a public or private institution based upon "race, color, creed or religion." Now, eighty-five years after the adoption of the Constitution's prohibition on discrimination, the State Legislature has discovered that we need an "Equal Rights Amendment" that ensures a "right" to an abortion in New York.

New York's abortion laws are already among the most permissive in the nation. Proposal One does nothing to alter the abortion laws or to further liberalize them. In fact, the word "abortion" does not appear anywhere in the proposed amendment. New Yorkers who vote in favor of Proposal One because they believe it will provide additional legal guarantees related to abortion are victims of a misleading campaign that masks the true purpose of the amendment.

Voters need only to read the language set forth in Proposal One to learn its actual purpose and to discern its potential for harm. While they will find no mention of abortion, voters will discover that, if adopted, Proposal One would prohibit discrimination based upon "gender identity" or "gender expression." This language would transform the laudable and longstanding anti-discrimination article in the State Constitution into a legal weapon that would force institutions across the state—public and private, religious, and secular—to accommodate the most radical forms of gender ideology.

Under this language, for example, a CYO girls' basketball team, or a local girls' soccer club, could be forced to allow a biological male to participate on the team if he wishes to do so because of his "gender expression." To bar such a person from the team would constitute an act of illegal discrimination.

The same language can be employed against health clubs, public and private schools, restaurants, and other public places to mandate that these institutions open their bathrooms and locker rooms to anyone, regardless of biological sex, based upon an individual's "gender identity." To restrict access to a bathroom or locker room according to biological sex would be another form of unconstitutional discrimination.

Furthermore, Proposal One would undermine the bedrock religious liberty protections that the State Constitution is supposed provide for Catholic parishes, schools, and hospitals, as well as for the religious institutions administered by other faiths. The amendment would expose a church or school to a lawsuit if, for example, it refused to hire a "transgender" catechist or dismissed an employee for the promotion of notions about gender that are antithetical to Church teaching. A teacher could demand to be called by a "preferred pronoun", as could any student, regardless of age. A refusal to adopt this sort of language regime would violate the Constitution.

Catholic hospitals that do not perform gender-related surgeries could be sued for illegal discrimination against people who wish to express their gender identity through a medical procedure.

Supporters of Proposal One dismiss these concerns as far-fetched fearmongering. Yet they cannot offer any other plausible application of the language in the amendment. Unlike proposals in other states that were designed to limit the power of a state legislature to regulate access to abortion, Proposal One never mentions abortion, nor does it expressly restrict the power of the State Legislature to pass laws related to abortion. Instead, the amendment adds a "word salad" of terms to the State Constitution that would turn the shield of anti-discrimination protection into a sword that can be used to pierce religious and secular institutions in order to impose, by force of law, a gender ideology that voters have never endorsed.

New York's Constitution has, for nearly a century, expressly prohibited discriminatory practices. Proposal One does nothing to enhance the universally accepted principle of equality before the law. Proposal One is, instead, a deceptive effort to impose an ideological agenda upon the State disguised by popular and inoffensive rhetoric about "equal rights" and by appealing to voters who believe the state's abortion laws are at risk of change. But, to paraphrase the Gospel, by its language you shall know it. The words of Proposal One reveal its true intent and the effects it would have if adopted.

New Yorkers who do not wish to see the State Constitution used to implement a harmful gender ideology that would reach into nearly every facet of ever day life, from sports to schools, from bathrooms to gyms to hospitals—even into churches, synagogues and mosques—must vote "NO" on Proposal One.

An Unlikely Optimist

Although Bartimaeus was blind, Jesus stayed where he was and let the blind man come to Him. If he really wanted to be cured, he would find a way to get to Jesus.

It was obvious that the man was blind, and yet Jesus asked him "What do you want me to do for you?" The man had to clearly name his problem, and do so himself. If one of us needs to be cured of something, whether blindness, alcoholism, depression or any addiction, then we need to come to Jesus and tell Him what's wrong. We need to NAME it. Of course he knows our needs, and yet he says "Ask and you will receive." "Your heavenly Father will surely give to those who ask."

Bartimaeus's words were simple and uncomplicated. There was no long speech, no haggling or wheedling. "I want to see" was his direct reply. And Jesus told him that his faith had healed him. Rightly, this blind man knew that Jesus would not turn away from the cry of the poor. He threw aside his old cloak, got up, and ran to Jesus. The old cloak may be a symbol for his past, his darkness, his despair. He made an act of hope-filled faith, and Jesus did not disappoint him. He was clear about what he wanted, and knew who could help him. That's why Bartimaeus has a lesson for us all.

Español <u>Domingo XXX del tiempo</u> Ordinario



EVANGELIO: SAN MARCOS 10, 46-52

En aquel tiempo, al salir Jesús de Jericó en compañía de sus discípulos y de mucha gente, un ciego, llamado Bartimeo, se hallaba sentado al borde del camino pidiendo limosna. Al oír que el que pasaba era Jesús Nazareno, comenzó a gritar: "Jesús, hijo de David, ten compasión de mí!" Muchos lo reprendían para que se callara, pero él seguía gritando todavía más fuerte: "Hijo de David, ten compasión de mi!" Jesús se detuvo entonces y dijo: "Llámenlo". Y llamaron al ciego, diciéndole: "Ánimo! Levántate, porque él te llama". El ciego tiró su manto, de un salto se puso en pie y se acercó a Jesús. Entonces le dijo Jesús: "Qué quieres que haga por ti?" El ciego le contestó: "Maestro, que pueda ver". Jesús le dijo: "Vete; tu fe te ha salvado". Al momento recobró la vista y comenzó a seguirlo por el camino.



En el evangelio de hoy, Maros nos relata la última escena de Jesús en su camino hacia Jerusalén. Se

sitúa en Jericó, la ciudad desde la que se subía a la ciudad santa en el peregrinar de los que venían desde Galilea. Jesús se encuentra al borde del camino a un ciego, que está marginalizado de la sociedad, como correspondía a todos los que padecían alguna tara física. No se contenta el ciego de Jericó con las limosnas que le ofrecen los numerosos viajeros que suben a Jerusalén; quiere algo más, que nadie le quiere facilitar. Incluso intentarán acallar su grito ante el paso del Hijo de David. A pesar de su ceguera sabía él que sólo el Mesías le podría curar su deficiencia; de ahí que su ansia por ver se convierta en grito clamoroso que llega hasta Jesús. La ceguera es una esclavitud de la que Bartimeo quiere liberarse. El grito de Bartimeo se centra en conseguir la luz que le falta. En esta experiencia de la necesidad, de la falta de visión ante tantas contrariedades y dificultades de la existencia, la que nos lleva a pedir a Dios con verdadero deseo que nos conceda ver.





EVANGELHO: SÃO MARCOS 10, 46-52

Naquele tempo, quando Jesus ia a sair de Jericó com os discípulos e uma grande multidão, estava um cego, chamado Bartimeu, filho de Timeu, a pedir esmola à beira do caminho. Ao ouvir dizer que era Jesus de Nazaré que passava, começou a gritar: "Jesus, Filho de David, tem piedade de mim". Muitos repreendiamno para que se calasse. Mas ele gritava cada vez mais: "Filho de David, tem piedade de mim". Jesus parou e disse: "Chamai-o". Chamaram então o cego e disseram-lhe: "Coragem! Levanta-te, que ele está a chamar-te". O cego atirou fora a capa, deu um salto e foi ter com Jesus. Jesus perguntou-lhe: "Que queres que eu te faça?" O cego respondeu-lhe: "Mestre, que eu veja". Jesus disse-lhe: "Vai: a tua fé te salvou". Logo ele recuperou a

vista e seguiu Jesus pelo caminho.



Nos domingos anteriores, a liturgia apresentou/nos trechos tirados da parte central do Evangelho de Marcos. Alí, por três vezes, Jesus indica aos seus discípulos a meta da viagem: vai para Jerusalém para entrega a vida. Já percorreu uma boa parte do seu caminho: partiu da Galileia, desceu ao longo do rio Jordão e agora encontra-se em Jericó. Jericó, a cidade das Palmeiras, é um oásis situado na margem do rio Jordão, a cerca de 30 kilómetros de Jerusalém. Considerada a cidade mais antiga do mundo, está a cerca de 250 metros abaixo do nível do mar. Foi por

Jericó que os hebreus vindos do Egipto, conduzidos por Josué, entraram na Terra Prometida. Na época de Jesus, era uma cidade importante. Quando Jesus e os discípulos estão a sair de Jericó para retomarem o caminho para Jerusalém, deparam-se com um homem sentado à beira do caminho. Esse homem é cego e chama-se Bartimeu. Os cegos faziam parte do grupo dos excluídos da sociedade de Israel. As deficiências físicas eram consideradas como resultado do pecado. Os cegos eram impedidos de servir de testemunhas no tribunal e de participar nas cerimonias religiosas no Templo. O Evangelho, através da história do cego Bartimeu, propõe-nos uma parábola sobre a passagem da escuridão para a luz, da vida velha para a vida nova. O encontro com Jesus é sempre uma oportunidade para abraçar uma existência com horizontes mais amplos, uma vida plena de luz e de sentido.



"Eles partiram com lágrimas nos olhos e Eu vou trazêlos no meio de consolações". (Jeremias 31, 8).

A primeira leitura é um convite à alegria. Para o Povo que caminha pelos vales sombrias da vida e da história, Deus é um Pai que acompanha, que ampara e que cuida. Ele não deixará ninguém para trás, nem sequer os mais débeis — o cego, o coxo, a mulher grávida. Guiados pelo amor paternal de Deus, todos chegarão à terra sonhada, à meta da Vida verdadeira.
